## ANTI – RAGGING MESSAGE

Policies of JNTUA & AITS, against the ragging are in accordance with the directions of Hon'ble Supreme Court of India, UGC & other regulatory bodies. JNTUA & college management take the most stringent view against any act of ragging & all the prospective students are warned against indulging in any act & abetment of ragging & their guardians are advised to sensitize & advise their wards against the same, which may lead to most severe punishment including the initiation of criminal proceedings. The student and their guardians are strongly adviced to read the rulings of Hon'ble Supreme Court of India, UGC or APSCHE or University.

## What is Ragging ?

Any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing or handling with rudeness any other students, indulging in rowdy or indisciplined activities which cause annoyance, hardship or psychological harm or to rise fear in a fresher or a junior students or asking the students to do any act or perform something which such student will not in the ordinary course do & which causes a sense of shame or embarrassment, so as to adversely affect the psyche or physique of a fresher or a junior student.

All the students may note that they have given the signed undertaking to the college office in the prescribed format & have registered in the Anti – Ragging website & as well aware of the punishments against ragging.

UGC, AICTE, Andhra Pradesh State Council of Higher Education, affiliating university & police department have given wide publicity & announced the help line numbers to report on any teasing & ragging issues. Punishments are there for the people indulging in such activities & on the institutions also when they lack in vigilance & when they won't act as per the Supreme Court Guidelines.

AITS, has constituted daily monitoring committees, review committees, anti-ragging cells, quick response teams along with the contact details of the various co-ordinators and members of the above committees & teams. In addition, Superintendent of Police & the District Administration have published the police help line numbers in the news papers & announced in TV and electronic media.

In this connection, all the students are hereby advised to remember the punishments on ragging/teasing & seriously warned not to be with the erring students of any institution who ever involve in teasing/ragging issues.
