4. All the Committee members are attended in the meeting in virtual mode using teams app.

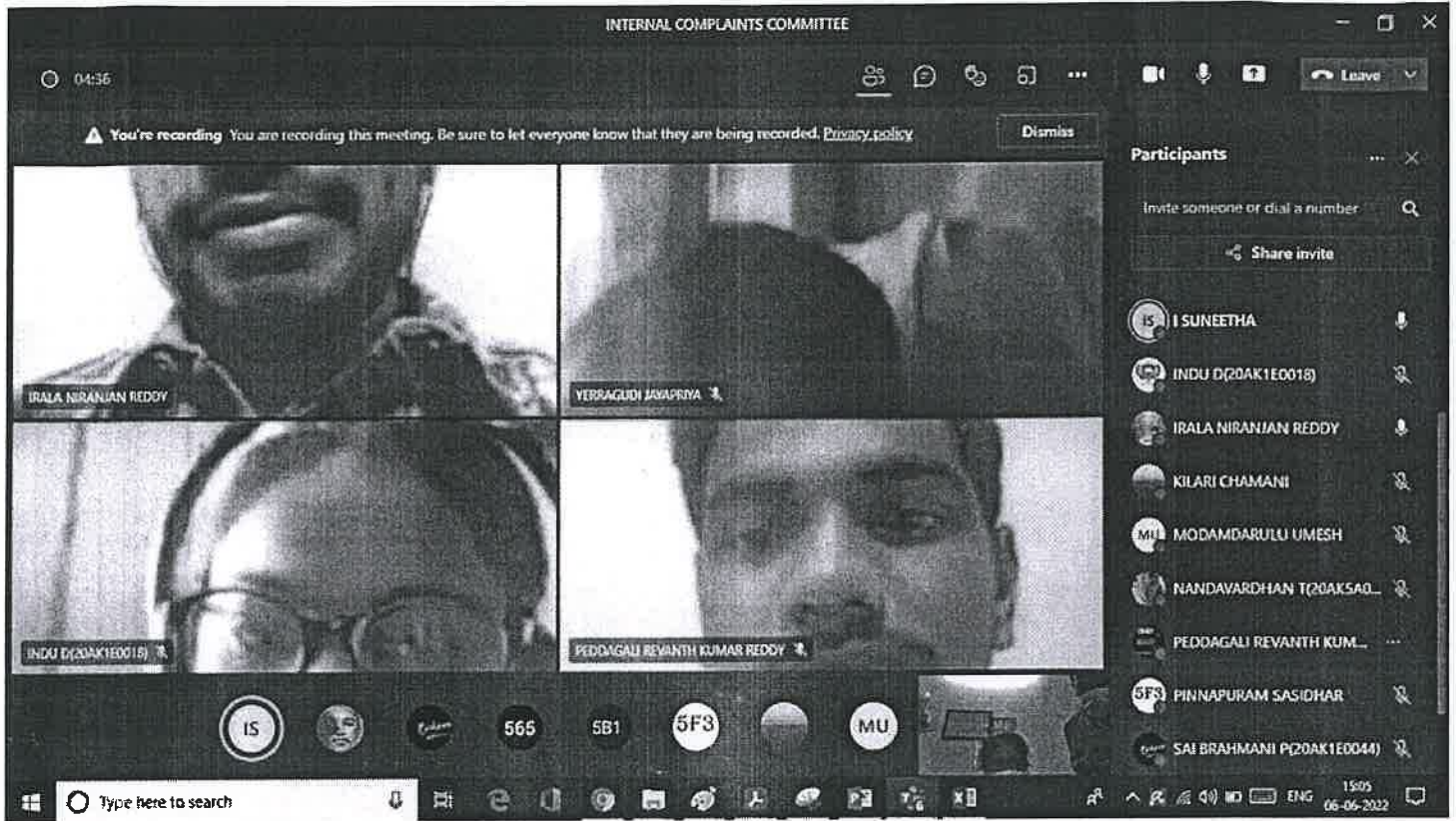

**Action Taken:**

1. Complaint registered in WPC & ICC , AITS.TPT on 28/07/2022
2. WPC convener made a call to Mr.S.Venkata Ramana to come to college and meet WPC chairman and convener
3. Parents along with Mr.S.Venkata Ramana met on 30-07-2022.
4. WPC chairman and Convener & ICC Presiding Officer explained the problem to his parents and told about the consequences of eve teasing/ women harassment.
5. After long discussions, Mr.S.Venkata Ramana and his parents accepted Mr.S.Venkata Ramana's mistake and gave assurance that here after he will not indulge in any kind of such matters related to girls.
6. The same has taken in the form of undertaken from Mr. S. Venkata Ramana and his parents
7. WPC Chairman, Convener and ICC Presiding Officer deleted all the messages, Whatsapp chat and contact numbers pertaining to Miss. K.Vaishnavi
8. Assurance taken from both parents and student not to do any offence to opposite person
