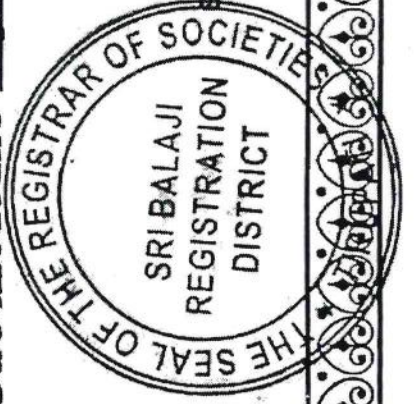

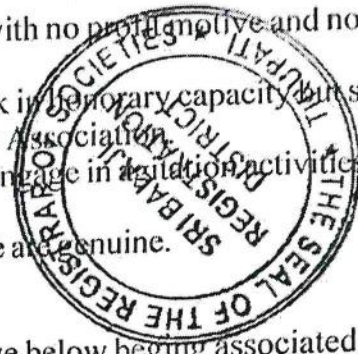

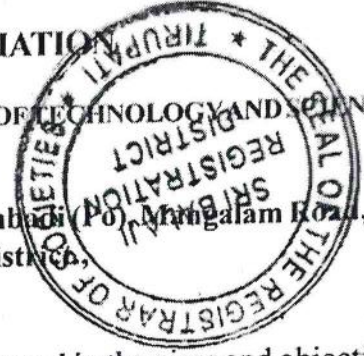

## RULES AND REGULATIONS OF ASSOCIATION

1. NAME OF THE ASSOCIATION :- ANNAMACHARYA INSTITUTE OF TECHNOLOGY AND SCIENCES ALUMNI ASSOCIATION
2. OFFICE ADDRESS :- Venkatapuram (V), Karakambadi (P), Mangalam Road, Renigunta (Mdl), Chittoor District, TIRUPATI
3. MEMBERSHIP :-



Any person, persons of the belonging to both sex, and is also interested in the aims and objectives of this association who is willing to abide by the rules and Regulations, of the Association sangam shall alone be the membership, if his general conduct and character are good.

a) Member should pay his subscription regularly. If any of the members become defaulter he/she is liable to lose membership and power of voting. Membership could be restored to any person put in request later to the president.

b) If any member of the group wants to separate himself from the main or head quarters association. He/She or they will not be entitled to any share in the assets or liabilities of the association.

c) The office beares, and other members of the governing body shall be elected by the General Body of the Association and shall have to hold office for a period of one year and may continue to be in office till the new committee or the governing body is elected and assume office on the 1st day of January.

### 4. EXPULSION OF MEMBERS.

The association reserves the right to expel any member in case any person or persons constitution it acts in contravention of the objects the association, or its activities and also determined to the interests of General Body meeting of the association specially called for the purpose by the majority of votes at least 3/4 of the total number of present at the meeting which ever is higher.

### 5. PRIVILEGES OF MEMBERS

Every member shall be entitled.

## 6. GENERAL FUNDS OF THE ASSOCIATION :

c) The minutes of the meeting of the Executive Committee will be recored in the minutes book by the Secretary of the Association.

## 9. POWERS OF THE OFFICE BEARERS OF THE ASSOCIATION:

The President shall be elected by the General Body.

1) The president shall be solemnly responsible for the over all administration of the association for making representations to the governing for concerned officials if needed. He is empowered to allot duties to the Executive Committee members.

2) The president shall be empowered to convene meeting of the association in executive committee at any time if he/she feels necessary in consultation with the secretary.

5) **SECRETARY :**


The Secretary shall be elected by the General Body.
